



DELEGATE'S REPORT JUNE 2024

It is June and time yet again for the Delegates to meet in beautiful downtown Newark. Well... not really downtown Newark, more like Newark Airport environs. Not much happened at this meeting, it was very quiet.

The most important thing we had to vote on was to yet again decide whether AKC Board members should be term-limited or not. When I first became your fearless delegate there were no term limits for Board members and it seemed as if the members were permanently ensconced in their positions despite their rather advanced ages. So, since it was very much in vogue at the time, term limits were established. Yet again, they were asking to have limits removed. Yet again the proposal did not pass. What happens now a member may serve two terms and then may take a year (or more) off and then reapply if he/she so wishes.

We also voted upon recommendations concerning field trials for Pointing breeds. Duh..... And a rather long recommendation concerning reorganizing and clarifying standing rules for standing Delegate Committees. I won't bore you with the details it is too arduous.

Other things discussed. There was talk about judges being required to learn how to work with Juniors. I believe there now is an on-line course they can take. Also discussed briefly was the CDC regulations concerning importing dogs, especially from Canada. The AKC is working with the CDC and Canada and the following came the other day. Congratulations to Ava Hatta, Olivia and Breanna Uyeno, and heartfelt thanks to Maribeth O'Neill for her dedication and devotion to all the Juniors, not only ours. Yesterday (July 22, 2024), the Centers for Disease Control (CDC) provided an update to related to new CDC requirements effective August 1 for importing or traveling into the United States with a dog older than 6 months of age.

The revisions to the rule no longer require an additional rabies vaccination form certified by a USDA-accredited veterinarian or an official government veterinarian in the exporting country. Instead, for dogs entering the U.S. from low-risk or dogmaintained rabies virus variant (DMRVV)-free countries like Canada, the revised rule simplifies entry by requiring one form—the CDC Dog Import Form—that does not have to be endorsed by a veterinarian. This form requires the dog's microchip number, a picture, and an attestation that the dog has not been in a high-risk country in the past six months.

Additionally, instead of making travelers update this form for every entry, it will now be valid for six months. However, CDC will continue to require all dogs entering the U.S. to be at least six-months old and be microchipped.

As stated in the update:

"To provide greater flexibility to the requirements for dogs coming from dog rabiesfree or low-risk countries, when the rule goes into effect on August 1, 2024..., dogs that have spent the prior six months only in dog rabies-free or low-risk rabies countries will be able to enter the United States with a CDC Import Form online submission receipt as acceptable documentation.

This form can be filled out the day of travel and the receipt can be shown to airlines and border officials as a printed copy or by phone. The receipt will be good for travel into the U.S. for six months from the date of issuance, including multiple entries.

All dogs entering the United States must have a microchip and be over six months of age."

The online CDC Dog Import Form, and other information regarding bringing dogs into the United States from low-risk countries <u>may be found on the CDC website</u>.

AKC continues to be concerned with the disproportionate impacts the new rule will have on low-risk importations for dogs between 4 and 6 months of age. We urge you to send respectful comments to CDC and your members of Congress regarding this issue.



Health Report - Michelle Barlak

Cornell University is collecting dna samples from dogs affected by Legg-Calve-Perthes disease for a study to look for genetic indicators for the disease. They are looking at multiple breeds but if enough Manchester Terrier samples can be collected, they will try to look for a genetic mutation and hopefully be able to develop a test for our breed. Please consider participating if you have a dog with LCP. If you are a breeder who has produced a dog with LCP, please reach out to the dog's owners and ask that they submit the DNA for the study. There are two ways to submit DNA, you can send blood that your vet collects or you can sign a release that will allow Embark to share your dog's DNA if you have done an Embark Panel on your dog. If you have a dog that fits thecriteria, please contact jessica.hayward@cornell.edu.



LEGG-CALVÉPERTHES DISEASE (LCPD) HEALTH STUDY

Legg-Calvé-Perthes Disease (LCPD) is a complex disease characterized by slow destruction of the femoral head accompanied by clinical signs of hip pain and lameness. Cornell University is conducting research to investigate the genetic predisposition for this disease, with the aim to develop a genetic test for informed breeding decisions. We have identified a suggestive genetic association for LCPD in small breed dogs but we need to collect more samples to validate this finding.

If your dog has been diagnosed with LCPD, you can help us!

What we need

- blood sample approximately 2-3mL EDTA blood drawn by your local veterinarian or,
- raw genotype data if your dog has an EMBARK profile
- a signed owner consent form
- pet information form
- pelvic radiographs to confirm diagnosis, if available

We will provide tubes and cover costs of sample shipping.

American Manchester Terrier Club Code of Ethics

Membership in the American Manchester Terrier Club (AMTC) is a privilege. In return for acceptance into the AMTC, I promise to abide by the following Code of Ethics and to submit to the enforcement of this Code by the AMTC Board of Directors.

GENERAL

I pledge as an owner of Manchester Terriers to be responsible for the dogs in my care. My responsibilities include providing proper shelter which is clean, dry and warm; appropriate veterinary care and inoculations; emergency veterinary care when needed; quality food and water; adherence to local and state animal control and licensing laws.

BREEDING

I pledge:

- 1. To accept and uphold the Standard of the Manchester Terrier as developed by the AMTC and approved by the AKC.
- 2. To breed only physically and mentally sound Manchester Terriers in order to maintain or improve the qualities of the breed as set forth in the Standard. I will not participate in the indiscriminate breeding of studs or bitches with no regard to quality.
- 3. To screen or obtain proof of screening of breeding stock for communicable diseases, hereditary faults or defects, either active or dormant. Questionable animals will not be used in my breeding program.
- 4. To forego breeding unless financially capable and willing to responsibly and caringly maintain whelped puppies until placed in their new homes.
- 5. To maintain complete and accurate breeding records in accordance with AKC regulations.

SELLING

I pledge:

- 1. To in no way misrepresent any Manchester Terrier for sale.
- 2. To provide all buyers with:
- A. AKC individual registration application or certificate properly filled out by seller.
- B. Minimum three-generation pedigree.
- C. Record of inoculations, worming, etc.
- D. Provide instructions for feeding and care.
- E. Be available for guidance and questions.
- 3. Not to sell, give, trade, abandon or in any manner transfer litters or individual Manchester Terriers to pet dealers, pet wholesalers, auctions, laboratories, raffles, pet stores, puppy mills, animal shelters, or any source for resale. I will not knowingly transfer ownership or provide stud service to anyone who intends to breed Manchester Terriers for any of the above listed purposes.
- 4. To take back any Manchester Terrier I bred if the current owner of the dog can no longer keep him or her. I will evaluate the dog as to whether or not s/he is suitable for placing in a new home. In the very unfortunate circumstance that the dog is not suitable, I will either keep the dog myself or provide proper veterinary euthanasia. In the rare event that I cannot take back a dog due to current personal circumstances, I will place the dog in AMTC rescue. I, the breeder, will reimburse any and all reasonable expenses incurred on behalf of a dog in this unusual situation to AMTC rescue.

EXHIBITING

I pledge:

- 1. To serve as an example of good sportsmanship in any aspect of the sport of dogs, assisting and befriending newcomers to the best of my ability.
- To show only those Manchester Terriers which deserve to be champions in light of the Standard and which are in proper condition.
- 3. Not to kennel pack for points in conformation or to engage in any other unfair practices in competition.

PENALTIES

I acknowledge and accept for disciplinary purposes a sliding scale of penalties based upon the seriousness of the deviation from this Code of Ethics. The Board of Directors will apply penalties equally to any and all offenders after a proper review of the evidence. Penalties include but are not limited to: reprimand from the Board; temporary suspension from AMTC membership; permanent suspension from AMTC membership; reporting offenders to the AKC; withholding AMTC awards. I have read and I promise to abide by the above Code of Ethics as set forth by the AMTC.
